Mr. Steve Parker, NJ licensed engineer, appeared before the board. The alteration is for an existing 4-bedroom dwelling. A real estate transfer occurred, and the client is the new owner. The owners are aware of maintenance requirements and deed restriction requirements.

- 2. The swale was questioned on the map.
- 3. The 3-1 slope has to be more than 3-1. It should be a 5-1 slope to prevent breakout.

Mr. Jupinka responded:

- 1. They tested the soil on the side but the soil there was worse. As for the flat area in the back, the residents would like to preserve some areas for future use.
- 2. The swale is on most of our drawings.
- 3. I can certainly do that.
