

**MEETING MINUTES OF THE

A. CALL TO ORDER

- a. Sharon Bobnar-Becker **CALLED THE MEETING TO ORDER** at 7:35 pm.

B. ATTENDANCE

C. APPROVAL OF THE MINUTES

- a. Mr. Toman made a **MOTION TO APPROVE** the minutes of the April 3, 2019 meeting of the Recreation Committee. **SECONDED** by Mr. Hunt. **VOTE: YES:** All present (Ms. Adams joined the meeting later.) The motion passed 4-0.

D. OLD BUSINESS

- a. **Jim Rohl Scholarship:** Director Bolarakis distributed a chart with the applicants of the Jim Rohl Scholarship. The applicants were not identified by name on the spreadsheet Director Bolarakis distributed. The committee discussed the applications and reviewed who met the established criteria. Mr. Toman **MADE A MOTION** to give a \$500 scholarship each to applicants 6, 15, 16, 19, and 22. **SECONDED** by Mr. Hunt. **VOTE: YES:** All present (Ms. Adams joined the meeting later.) The motion passed 4-0.
- b. **Volunteer Awards & Dinner:** Director Bolarakis indicated that the department may need to postpone the Volunteer Dinner. The decision was made to make presentations for coach of the year at the Summer Spectacular.
- c. **Summer Road Park Basketball Court Renovation:** Director Bolarakis indicated that the renovation of the basketball courts at Summer Road Park is underway. The preliminary work was completed and the concrete has been poured. The next steps will be in about 3 weeks as the concrete cures. Director Bolarakis distributed pictures of the progress. The committee was very excited about the progress being made.

E. NEW BUSINESS

- a. **Travel Basketball SOP:** Director Bolarakis indicated some minor changes that needed to be made to the Travel Basketball SOP. These changes included clarification on professional training, coach's responsibilities, and coach's dress code. These changes will be distributed via email to the committee and a vote on the changes will take place at the next meeting.
