WHEREAS, the primary duty and responsibility of the State Planning Commission under the State Planning Act is the preparation of a "State Development and Redevelopment Plan;" and,

A. Any of the fire companies which comprise the Readington Township Fire Department as set forth in Chapter 21 of the Readington Township Code; or

B. The Whitehouse Volunteer Rescue Squad or any other rescue squad established in the Township of Readington, **or**,

C. The Office of Emergency Management and its appointed members.

D. Community Emergency Response Team (CERT) and its appointed members.

ORDINANCE REAPPROPRIATING \$16,161.67 FROM ORDINANCE 07-2021 PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSE IN ORDER TO PROVIDE FOR THE PURCHASE OF AN ALCOTEST MACHINE FOR THE POLICE DEPARTMENT IN AND BY THE TOWNSHIP OF READINGTON, IN THE COUNTY OF HUNTERDON, NEW JERSEY

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF READINGTON, IN THE COUNTY OF HUNTERDON, NEW JERSEY, AS FOLLOWS:

SECTION 1. Pursuant to NJSA 40A:2-39, It is hereby determined that \$16,161.67 of the proceeds of obligations originally made available pursuant to Ordinance #07-2021 of the Township of Readington, in the County of Hunterdon, New Jersey (the "Township"), finally adopted May 3, 2021, is no longer needed for the stated purposes.

SECTION 2. The \$16,161,.67 described in Section 1 and made available pursuant to N.J.S.A. 40A:2-39 is hereby reappropriated to provide for the purchase of an alcotest machine for the Police Department.

SECTION 3. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

SECTION 4. This ordinance shall take effect after final adoption and publication and otherwise as provided by the law.

SECTION 5. If any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause, or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

SECTION 6. The sections, subsections, and provisions of this Ordinance may be renumbered as necessary or practical for codification purposes.

SECTION 7. Any ordinance or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

SECTION 8. This Ordinance shall take effect upon passage and publication in accordance with applicable law.

6. Resolution Calling for the Modernization of the Open Public Records Act (OPRA) and the Swift Passage of S-2930/A-4045

The following resolution was offered for consideration:

TOWNSHIP OF READINGTON RESOLUTION CALLING FOR THE MODERNAZATION OF THE OPEN PUBLIC RECORDS ACT (OPRA) AND THE SWIFT PASSAGE OF S-2930/A-4045

WHEREAS, in the 2002 "lame duck" session the Open Public Records Act (OPRA) was approved to make government records, "readily accessible for inspection, copying, or examination by the citizens of this State, with certain exceptions, for the protection of the public interest" while protecting "a citizen's right to a reasonable expectation of privacy"; and

WHEREAS, as local leaders we reaffirm our support and commitment to open and transparent government and public access to records, at the same time, we strongly support necessary reforms; and WHEREAS, in the twenty years since the enactment of OPRA and with the advent of new technologies, we have witnessed unintended consequences and, in some cases, abuses of OPRA that place an unfair burden on local governments and taxpayers; and

WHEREAS, municipal staff and budgets are increasingly utilized to accommodate the requestors and commercial entities who inundate municipalities with public records requests to the extent that in some instances, additional personnel are hired primarily to handle such requests; and

WHEREAS, OPRA has become broadly construed in favor of access and the requestor who prevails in any proceeding in appealing a denial of access of records is permitted to collect exorbitant attorney's fees, which impacts the taxpayers and municipalities who must pay these fees; and

WHEREAS, municipalities have seen outside businesses and interests who abuse OPRA for marketing and commercial gains while utilizing municipal employees paid by the taxpayers for this benefit; and

WHEREAS, due to court decisions over the years, reasonable expectations of privacy have been diminished when it comes to the balance of transparency and OPRA perpetuates forprofit datamining, unsolicited marketing, and uncontrolled publications of records on internet search engines specifically designed to circumvent and bypass what few protective measures currently exist under OPRA, all while allowing the requestor to remain cloaked in anonymity, should they choose to exercise that option; and

WHEREAS, when commercial entities are constantly emailing OPRA requests looking for the latest lists of dogs licensed that month, inground pool permits issued, solar roof permits issued, etc., it causes our residents to not want to license their dogs, comply with permits, or interact with the municipality because they don't want to lose their privacy and/or have their information tracked and monetized for commercial purposes; and

WHEREAS, reforms to modernize OPRA are long overdue, among them: the need to address requests by commercial entities that utilize public records and the services of local government employees to generate profits, mandatory prevailing attorney fees, which created a cottage industry, and to add language so that such fees are based on facts and circumstances and not an automatic granting; and

WHEREAS, Senators Sarlo and Bucco and Assemblyman Danielsen and Assemblywoman Flynn have introduced S-2930/A-4045, which makes commonsense reforms that do not hinder residents or journalists from using OPRA to access public records, but will protect citizens' personal information from disclosure, addresses the burdensome commercial requests and provide discretion when awarding prevailing attorney fees;

WHEREAS, pursuant to Ordinance #02-2022 adopted on February 7, 2022 (Readington Township Code Section 88-1 et seq.), the Township of Readington ("Township") published notice on April 28, 2022 inviting applications for one (1) municipal business license for a cannabis establishment (adult use) to be located within the Licensed Cannabis Business Overlay ("LCBO") Zone District in the Township; and

WHEREAS, the Township received an application on July 20, 2022 from Verano, NJ, LLC ("Applicant") for municipal business licenses to operate as both a Class 1 cannabis cultivator and Class 2 cannabis manufacturer on property it leases from Branchburg Route 22, LLC ("Owner"), which property is known as Block 14, Lot 49 on the official tax map of the Township and is commonly known as of 3576 Hwy. 22, Whitehouse Station, N.J (the "Property"); and

WHEREAS, the Applicant submitted additional documentation to the Township in support of its application on October 26, 2022 and on January 20, 2023, respectively, after having been notified on August 25, 2022 and December 26, 2022, respectively, that the Township's Cannabis Business Application Review Committee (the subcommittee which was charged with reviewing the application for recommendation to the Township Committee), had found it to be incomplete as to several items; and

WHEREAS, the Township's Cannabis Business Application Review Committee reviewed the January 20, 2023 submission, and on March 24, 2023 provided the Township with its recommendation of approval with conditions, which conditions the Township Committee agrees should be imposed; and

WHEREAS, the Applicant has been operating at the Property as a pre-existing state licensed Alternate Treatment Center pursuant to the "Jake Honig Compassionate Use Medical Cannabis Act, "P.L. 2009, c. 307 (N.J.S.A. 24:61-1 et seq.), and has approval from the State of New Jersey to operate as an "expanded" ATC, meaning that it may cultivate and process/manufacture both medical and personal use cannabis at the Property, as a result of Class I (cultivator) and Class 2 (manufacturer) licenses #C000009 and #M000007, respectively, granted by the State of New Jersey Cannabis Regulatory Commission Office of Compliance and Licensing, on or about April 17, 2022; and

WHEREAS, the Applicant has requested the Township to supply a letter to the CRC in support of its application to renew its state expanded Alternative Treatment Center ("ATC") licenses #C000009 (Class I Cultivator) and #M000007 (Class 2 Manufacturer) which are due to expire on April 17, 2023; and

WHEREAS, in addition to the above, during the course of the application process, the Applicant has made certain tax payments to the Township pursuant to Township Code Sections 88-12, et seq. pertaining to the imposition of cannabis transfer and user taxes on adult use cannabis, as authorized by the State of New Jersey; and

WHEREAS, the Township Committee does not believe that it has thus far received sufficient information supporting the amount paid toward the transfer/user taxes, in terms of accounting and/or characterization, and the Applicant does not agree with the amounts paid. Accordingly, both the Applicant and Township have agreed that the Township may have a forensic audit conducted, to be paid for by the Applicant, in order to review the information provided by the Applicant in conjunction with the transfer/user taxes. The choice of the auditing firm shall be the Township's; and

WHEREAS, the Township Committee agrees that the Applicant's application can be approved with conditions in order to facilitate the processing of the Applicant's state license renewals.

NOW, THEREFORE BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF READINGTON AS FOLLOWS:

- 1. The preambles above are incorporated herewith as if fully repeated herein.
- 2. The Township Committee approves the application of the Applicant, Verano NJ, LLC for municipal Class 1 "Cannabis Cultivator" and Class 2 "Cannabis Manufacturer" licenses in the Township of Readington to be used at the property known as Block 14, Lot 49 on the official tax map of the Township, commonly known as 3576 Hwy. 22, Whitehouse Station, NJ 08889,
- 3. This license approval shall run from May 22, 2024 and shall expire on May 22, 2025. All future annual municipal license renewal applications shall be submitted at least 90 days' prior to the expiration date of the municipal licenses issue.
